KiSS will offer the only automated and interactive business 100% turnkey business solution in the market place today. The KiSS system will offer the only and 'first' low barrier of entry and growth opportunity for the masses that has perfect duplication from exposure to getting started.

2. Q: Do I need to do anything to become a member?

Yes. Participants must become a KiSS Identity Drivers with an identification number and username. Additionally, participants can only get a Driver identification number by referral. They will visit a referral driver self replicated website at www.mykissid.com/username from the referral driver. There they will see an overview video and have an opportunity to sign up now through an ENROLL NOW link at the bottom of the page to register and become a driver... It's easy and it's FREE!

A cover charge is the personal product purchase that a driver selected for their qualifying monthly shipment. Drivers chose one of the KiSS Identity products that they want delivered each month.

7. Q: How do I create my Auto-Ship Cover Charge?

In your www.mykissid.com/username back office you will have a tab labeled order. Select the Order button and within this menu you will find a 'Manage Cover Charge' area. Here you will be able to select your monthly auto shipment of KiSS products. In the beginning the selection will be very exclusive and will expand overtime. Check back frequently as you can update and change your auto ship frequently.

8. Q: Do my KiSS Identity Commissions have a cash value?

Yes. This is real money that you can use in whatever ways you would like. You will need to establish a payment method from the KiSS website. Each account is safe, secure and easy to set up. Once you have set up your account we will send you money that will be directed into an account of your choice. This is a convenient way to get paid for sharing a KiSS, building a brand and getting paid.

9. Q: How many commissions can I earn?

The more personal drivers you refer and the more they refer the bigger brand you help to build, the more you can earn. See the compensation PDF's to fully appreciate the financial opportunity associated with being a KiSS driver.

10. Q: How often do I need to qualify for my position as a KiSS Identity Driver?

Each month! It is simple for drivers wishing to earn commissions in any given month they must be a registered and qualified driver in order to earn KiSS Identity commissions. If a driver has gone into "In-Active" status they may re-activate their status by making the minimum purchase amount required by respective membership requirement and the following month they will be re-activated.

Qualified driver is defined as a person who has purchased and paid for the cover charge, which is the minimum monthly personal purchase requirement of \$10.00. The products must be purchased using their own KiSS Identity webpage and driver number.

11. Q: Can I enter by postal mail or over the phone?

No. You can only participate in this business opportunity by registering online through an electronic invitation and completing the driver enrollment process.

12. Q: Who can participate in KiSS Identity?

All customers 18 years of age and older within the contiguous 50 US States and Canada are eligible as of April 1st 2009 can enroll as a member and participate in the program. There is no fee for enrolling or participating in the program.

KiSS Identity reserves the right to terminate customers or drivers from the program based on violations of promotion terms and conditions, fraud or appearance of fraud, or violation of any federal, state, or local law or regulation in connection with the use of program privileges. Customers and drivers terminated from the program will forfeit their KiSS Club immediately.

13. Q: Do I have to pay taxes if I earn commissions from KiSS Identity?

Yes. Drivers are responsible for determining, recording and paying all federal, state, and local taxes related to commissions. It is important that members keep records of all commissions, expenses and business dealings. KiSS Identity will not provide any tax information to customers or drivers. Drivers should consult with their tax advisors for tax guidelines specific to your needs. Any and all tax liabilities arising from the program are the sole responsibility of the drivers.
